1. INTRODUCTION

- 1.1 This Policy applies to the users natural persons who view, read or enter their data on the https://accolade.eu/ website (hereinafter the "Website") or who share their data with Accolade through third party websites. The purpose of this Policy is, among other things, to provide the users of the Website with relevant information on the use of cookies and the options to block them.
- 1.2 This Policy sets forth the rules governing collection, storage, processing and use of the data of the Accolade Website users, as well as Accolade using cookies for collecting and processing the Website users' data.
- 1.3 For the purposes of this Policy, cookies are defined as cookies and other similar technologies (such as pixel tags, web beacons or device IDs) that may automatically collect data during a visit to the Website. Information collected in this manner may include IP address, browser type, operating system, referring URL, information about activity on a page, dates and times when the page was visited.

2. WHAT ARE COOKIES?

2.1. Cookies are small text files containing small amount of data that may be stored on the device of the user visiting a website.2.2. Among others, cookies:

- a. are used to facilitate navigation through the website, for personalization, saving preferences and for overall improvement of a website's user experience;
- b. allow to learn whether the user visited the Website in the past or is a new user, as well as assist in maintaining statistics on Website users;
- c. facilitate displaying relevant ads on the Website to match the individual user's interests.
- 2.3. Cookies may be divided based on the entity placing them on the website, i.e. into:
 - a. **first party cookies** they are only valid for the domain of the website being viewed. These cookies are considered safer;
 - b. **third party cookies** these are placed through an external domain script. This allows to follow the users over more than one domain. They are often used to measure the effectiveness of advertising campaigns.

3. WHAT IS THE PURPOSE OF USING COOKIES?

3.1.

Accolade uses cookies on its Website for the following purposes:

- a. **essential** these files support the basic functionalities of the website (e.g. logging in) or the individual pages (e.g. watching videos, sharing content etc.); necessary cookies do not require user consent;
- b. **functional** facilitate navigation and improve the functionality of the Website, store the user preferences and improve safety;
- c. **analytical** collect non-anonymous user behavior data. Based on these files Accolade may customize the Website to improve user experience;

d. marketing

- remarketing used to target ads to users who have visited the Website before;
- conversion allow to measure the effectiveness of advertising campaigns.

ESSENTIAL COOKIES

When viewing and using the Website for informational purposes only, i.e. when the user does not register or does not grant consent, the data collected and transmitted to our server only includes the personal data necessary for viewing the Website and ensuring stability and safety of its use.

Facilitate navigation and improve the functionality of the Website. Are used to trigger specific Website functions and settings, depending on the user preferences (e.g. language). Functionality cookies are used to store user preferences for new visits to the Website and improve its safety. These cookies do not collect information that would allow to identify the user.

These cookies typically do not collect information that would allow to identify the user.

7. PERSONAL DATA PROCESSING, FURTHER USE OF DATA COLLECTED THROUGH THE WEBSITE

- 7.1. Accolade declares that as the personal data controller it processes all personal data, including personal data collected through the use of cookies, in accordance with the Regulation of the European Parliament and the (EU) Council 2016/679 on the protection of natural persons with regard to the processing of Personal Data and on the free movement of such data, and repealing Directive 95/46/EC (Global Data Protection Regulation) and related personal data protection and cookie storage regulations.

8. INFORMATION SHARING

8.1. Accolade can share data collected from a user's visit to the Website with external parties for the purpose of managing the Website or conducting marketing activities on behalf of the company.

9. CONNECTIONS WITH SOCIAL NETWORKS

9.1. Social network buttons available on the Website are provided to facilitate interaction with social networks and make the Website more attractive for users. Connection with a given social network will only be established when a user clicks the relevant button. In this case their browser connects with the servers of the relevant social network.

10. FINAL PROVISIONS

- 10.1.Accolade is entitled to introduce unilateral changes or to supplement this Policy at any time. Should any changes be introduced into this Policy, Accolade shall notify users about the changes in advance and in the proper manner to ensure that users can actually review the changes.
- 10.2. The Policy comes into effect and becomes binding as of 1 November 2018; last update February 2022.
