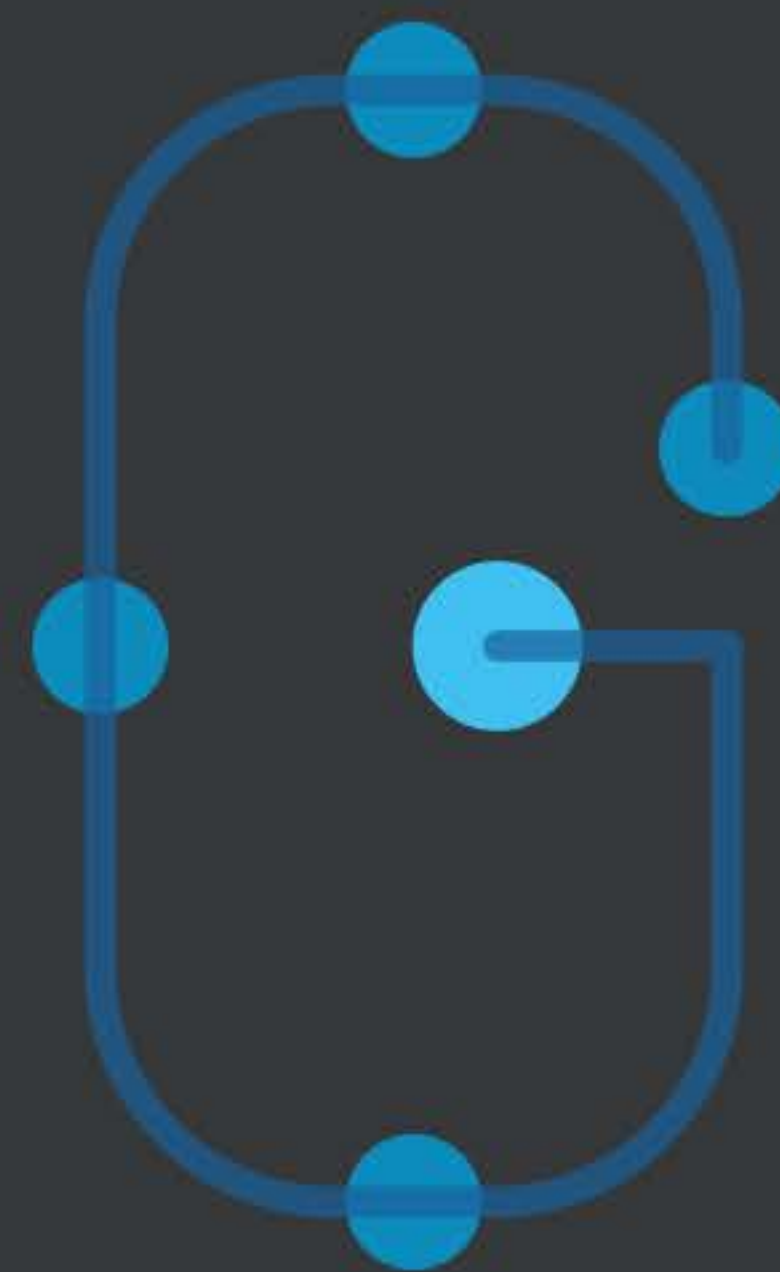

Accolade is focused on creating environmentally conscious portfolios in the real estate industry with green building certifications as a standard, such as BREEAM or DGNB. These certifications evaluate various aspects, including energy use, health and wellbeing, pollution, transport, water, materials, waste, ecology, and resilience. These certifications underscore the robust sustainability initiatives implemented at Park Cheb South, Park Szczecin III, Park Stribro, Park Konin or Park Kojetín. Historically, Park Cheb South and Park Szczecin III had been the first projects in the Czech Republic and Poland to receive the prestigious BREEAM sustainable construction certificate with an Outstanding rating for a new industrial building. Moreover, a facility at Park Cheb South industrial park is particularly notable for obtaining BREEAM Outstanding certification with the highest score. Accolade's successful transformation of the Park Cheb site further testifies to its eco-conscious ethos; this industrial park was built following a complete revitalization of a former brownfield site that once hosted engineering plants. These significant strides solidify Accolade's commitment to championing environmentally friendly practices within the sector of industrial real estate.

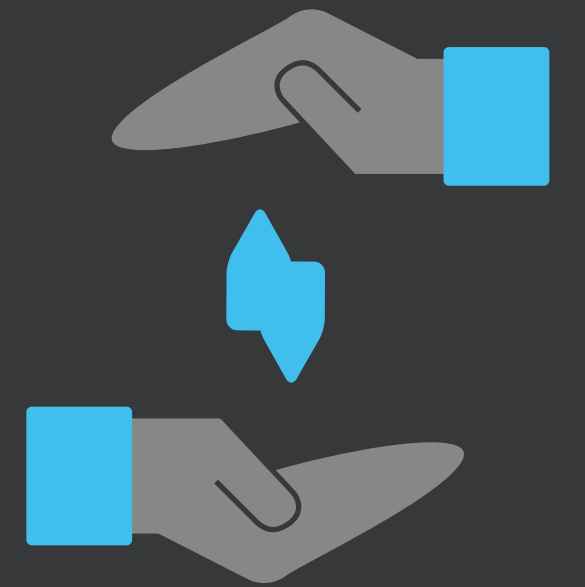

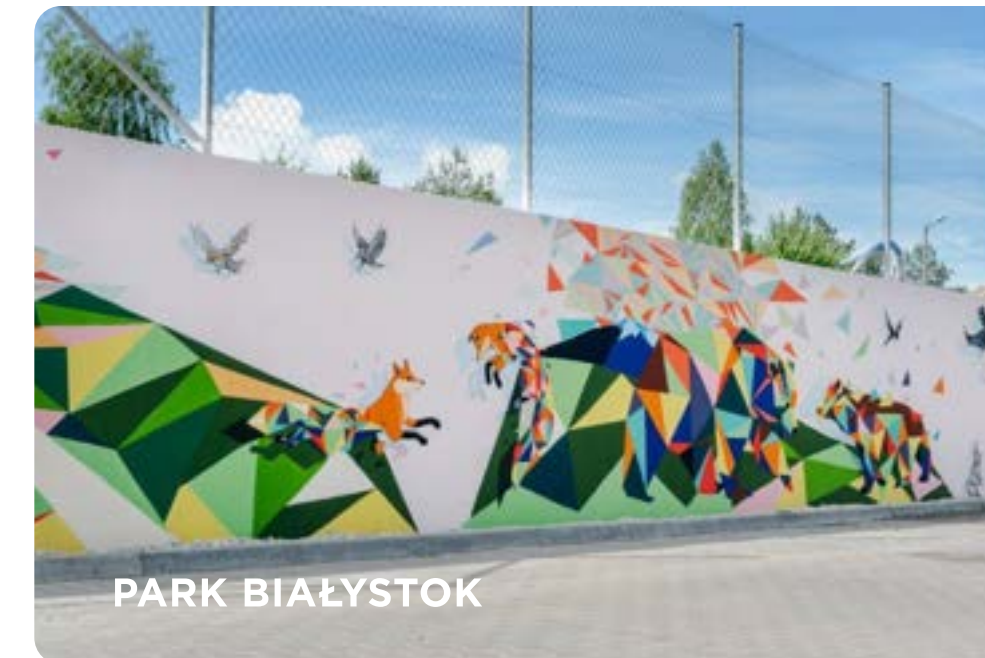


# SUPPORTING LOCAL COMMUNITIES

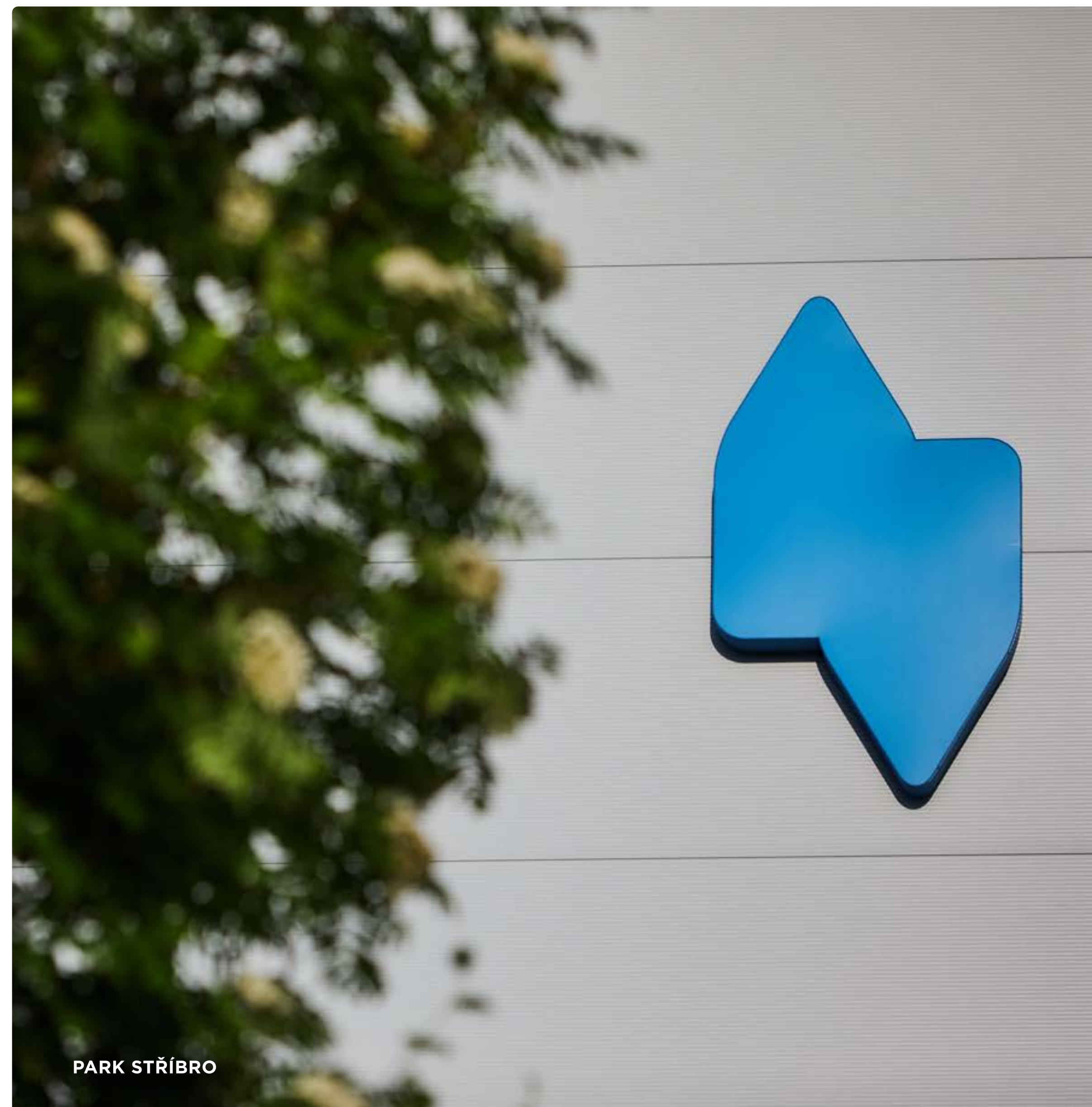




# INVESTING RESPONSIBLY
