

Personal Data Processing Notice

1. In the framework of the event “The Mural Art Competition”, Accolade, s.r.o, Sokolovská 394/17, Praga 8, 186 00 Karlín, Czech Republic, IČO (Registration Number) 27851371, entered into the Commercial Register of the Court of the City of Prague, division C, ref. no. 146043 (hereinafter “the Controller”) processes personal data of the event’s participants pursuant to Article 6(1)(b) of the REGULATION OF THE EUROPEAN PARLIAMENT AND COMMISSION (EU) 2016/679 (GDPR) (hereinafter referred to as the “Regulation”) to process requests, manage inquiries and provide services.
2. The personal data is processed in the following scope:

- name and surname
- e-mail address

This data will be processed by the Controller for the period necessary to process an inquiry or a request and provide a service, however not longer than 6 months since the last communication, provided that no other legal title of processing arises (for instance a consent).

5. We inform that pursuant to the Regulation you are entitled to the following:
 - raise an objection against personal data processing processed on the grounds of a justified legal interest,
 - request information about the processed personal data and a copy of the data from the Controller,
 - request explanations concerning personal data processing from the Controller,
 - request an access to the data and its update or amendment by the Controller,
 - request deleting the personal data by the Controller,

In case of any questions concerning complying with the obligations related to personal data processing, you can contact the Controller or the Personal Data Protection Office.

6. The Controller commits itself that pursuant to Article 32 of the Regulation, taking into account the state of the art, the costs of implementation and the nature, scope, context and purposes of processing as well as the risk of varying likelihood and severity for the rights and freedoms

of natural persons, it will implement all possible technical and organizational measures to provide personal data security in the way specified in legal act no. 110/2019 of the Journal of Laws concerning personal data processing, the Regulation and other commonly binding legislation in order to exclude the possibility of an illegal or incidental access to the Personal Data, its amendment, destruction or loss, illegitimate transmission, other illegitimate processing and other misuse of the Personal Data. The obligation continues also following the completion of Personal Data processing.

7. Within Personal Data processing no automated decision making or profiling is conducted.
